Summary:

The accused was convicted of sexual assault and was sentenced to two years' imprisonment. The accused applied for an extension of time to appeal the sentence.

The Saskatchewan Court of Appeal dismissed the application.

Criminal Law - Topic 6208

Sentencing - Appeals - Variation of sentence - Extension of time to appeal - The accused was convicted of sexual assault and was sentenced to two years' imprisonment, consecutive to a previous 18 month sentence - The sentencing judge had started to impose an 18 month sentence, but the accused interrupted and requested a sentence that would take him into the federal penitentiary system - Accordingly the two year sentence was imposed - The accused now sought an extension of time to appeal that sentence - He argued that he had requested two years because he wanted to be placed where he could receive sexual offender treatment and that he subsequently found that he could only receive treatment if he admitted he had sexually offended, which he would not do - The Saskatchewan Court of Appeal dismissed the application.
